## Director's Report

Marylu gave the Director's Report.
Circulation was down a little, but may be a trend comparable to other libraries. Holds are at 75\% from our own collections.
Budget is on track.
Door counter working great.
Received $\$ 1,000$ from Friends of the Library to spend on Summer Reading Program.
The Library will be closed April 19 and 20.
Annual Easter Egg Hunt will be on April 20 courtesy of Bob Theim, the Masons, Stephanie and Sue. On March 19, the County Board approved the resolution to amend the County Board Rules to have seven appointed members for the Library Board. No questions were asked about the library's Annual Report that was also in the Board packet.
Library Aide interview will take place the last week of April.
Springsted Wage Study: No further info, but the County is starting to get comparables.
Jeanne Heideman Scholarship: The Friends met on 4/9 to discuss the applications for their scholarship. Cassie was asked by Pat Townsend to address the committee and was well received.
Plants: The large plants have gone to good home. Volunteer Betty took excellent care of them for many years, and helped prepare them for moving.
Erin is out of the office April 10-15.
Items from March:

Is there an ALA policy on hate speech? No, because it is a very complex issue-hate speech is not illegal unless it advocates violence specifically. Erin prepared a sheet on the ALA recommendation for dealing with hate speech.
Confidentiality of patron records when using a collection agency? Erin had an article from the Library Journal from 2016. It lists what information can be shared with collection agencies and what cannot. Need for a policy on requesting a patron to change computer terminals? No need for a separate policy on the one issue. General policies on patron behavior are broad enough to cover patron behavior if it becomes abusive. We also have a complaint form a patron can use if they feel they have been mistreated.
